The Issuer entered into a consulting agreement with Global ATS Holding AG (“Global”) dated March 24, 2024, pursuant to which Global agreed to provide marketing services in Europe to the Issuer for a period of 60 days in consideration for up to EUR€100,000. The Issuer and Global are arm’s length parties.

The Issuer previously entered into a marketing agreement with i2i Marketing Group LLC (“i2i Marketing Group”) dated November 23, 2023, pursuant to which i2i Marketing Group agreed to provide marketing services for the Issuer for approximately 90 days in consideration for US\$300,000. On February 23, 2024, the Issuer announced that it extended the i2i Agreement for a period of 60 days or until fund exhaustion of US\$150,000. On March 18, 2024, the Issuer announced that it further extended the i2i Agreement for a period of 60 days or until fund exhaustion of US\$150,000. The Issuer and i2i Marketing Group are at arm’s length.
