On February 17, 2021, Sassy Gold Corp. (formerly, Sassy Resources Corporation) (“SASY”) entered into an option agreement (the “Option Agreement”) with Vulcan Minerals Inc. (“Vulcan”), of St. John’s, Newfoundland and Labrador, the registered and beneficial owner of certain mineral claims known as the “Gander” property located in Newfoundland and Labrador (the “Property”), pursuant to which Vulcan has agreed to grant the Issuer the exclusive option to acquire 100% interest in the Property. SASY filed a Form 9 with the CSE on February 17, 2021 with respect to the Option Agreement.

On February 28, 2021, the Issuer entered into an assignment agreement (the “Assignment Agreement”) with SASY and the right, title, interest and obligations was assigned to the Issuer.

On April 18, 2024, the Issuer entered into an amendment to the Assignment Agreement (the “Amendment Agreement”) with Vulcan to issue an additional 600,000 Shares to Vulcan in settlement of the cash portion owing.

The issuer is proceeding with the issuance of 1,000,000 Shares to Vulcan.

PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9
